If the teachers and masters of a country are getting caught up at fault then it is certain the real saints and sages must have gone in their solitude and masters of cunning art and pseudo/occult sciences must have entered into the emptied or left over space which can say to be sufficient to break the hell in the open circumventing the very spiritual understanding of the area.

#### (A). Broad outline

**A.1).** At the onset it can be submitted undersigned do not have any desire to hold any constitutional post whatsoever but firmly can submit that the implementation of the agenda submitted herein (and consequently offer for consultancy on free basis) is the only option for Bihar and entire India to survive and sustain itself and in coming days exhale and guide the comity of nation in
